POPI Act Compliance

In accordance with the Protection of Personal Information Act 4 of 2013 ("POPI"), the purpose of this privacy policy is set out to detail how, when and why Aurora Glycerine Soaps cc will use your personal information. By using our platform/s, you hereby agree to the processing of your personal information as detailed here.

While we respect your privacy and take the protection of your personal information very seriously, we pride ourselves on delivering the best possible service and experience on our website.

- Comply with any legal or regulatory obligations
- Undertake research for statistical purposes which will not include the dissemination of your personal information

We will retain your information for as long as:

- It's required or permitted by law and is in line with our internal retention policies
- It's required to uphold a contract between you and us
- You have agreed to us storing your personal information, unless you have requested otherwise
- Necessary to achieve the purpose/s for which this information was collected or processed

By accessing and/or using our platform/s, you consent to us retaining your personal information for no longer than necessary to achieve the purpose/s for which the information was initially collected or processed.

You have the right to request that we no longer contact you for the purposes of direct marketing by any form of electronic communication, such as email notifications by "opting out" of any direct marketing communications we may send to you.

Transactional emails are confirmations of the action and include purchase receipts, order confirmations, password resets, confirmations, and welcome emails to new subscribers.

While your personal information will not be sold to any third parties, for marketing purposes or otherwise, we may provide your personal information to:

- Our employees and/or third party service providers in order to enable them to assist us to interact with you via our platform/s for the ordering of goods or when delivering to you or a recipient on your behalf.
- Law enforcement, government officials, fraud detection agencies or other third parties when necessary or appropriate when investigating potential fraud, intellectual property infringements or any other illegal activities that expose us to legal liability, financial loss, to report or support an investigation into suspected illegal activity.
- Potential purchasers and/or professional advisors in the event of any reorganisation, merger, consolation, sale, joint venture, or other disposition of any/or all of our assets
- Service providers who assist with our business operations. They may only
 use your personal information in connection with the services they
 perform and not for their own benefits, and must treat such information
 as confidential.
- Our suppliers/delivery networks in order for them to liaise directly with you regarding your purchases/deliveries.

Your information is secured by taking appropriate, reasonable technical and organisational measures to prevent loss of, damage, unauthorised destruction, unlawful access to or processing of your personal information. In order to achieve this, our policies, controls and related processes are reviewed and updated regularly. This covers but is not limited to:

- Provide you with reasonable evidence of our compliance under this privacy policy on reasonable notice and request.
- Notify you of unauthorised access to your personal information.
- Submit a complaint to the information regulator.
